I recognize the risks involved and willingly assume the risks associated with participation and accept that there are also risks that may arise due to other participants which I also willingly assume. The undersigned understands that Taller de José does not carry medical insurance to cover any possible losses the undersigned may incur as a result of his or her voluntary participation in this event. The undersigned is encouraged to have a medical physical exam and purchase health insurance prior to any and all participation.
